

ARTICLE V OFFICERS AND ELECTIONS

Section 5.1 Elected Officers

The officers of the association shall be President, Vice President, Secretary, Treasurer, VP for Membership, VP for Programs and SECA Representative.

Section 5.2 Elections and Terms of Office

- (a) The members of the Association shall elect President, Vice President, Secretary, Treasurer, VP for Membership, and VP for Programs.
- (b) An election shall be held annually by electronic ballot emailed to members.
- (c) Beginning in 2024 the President shall be elected to begin service in 2025. Thereafter the term for President shall be 3 years as President, then 3 years as SECA Representative. A new President will be elected every 3rd year.
- (d) In even years the Secretary, Vice President and the Vice President of Programs shall be elected to begin a two year service the next year. In the odd years the Vice President of Membership and the Treasurer will be elected to begin a two year service the next year.
- (e) Officers are expected to attend Board meetings prior to taking office on January 1 after the election
- (f) No officer shall serve more than two (2) consecutive terms.

Section 5.3 Duties

The individual duties of Officers are defined in KAECE Policy Manual. All officers shall:

- (a) Attend Board and Committee meetings and functions as required.
- (b) Submit reports and review the agenda prior to Board meetings.
- (c) Assist in recruitment
- (d) Keep abreast of updates in the professional field.
- (e) Follow fiduciary, confidentiality, conflict of interest and other policies as defined in the KAECE and SECA Bylaws and Policy Manual.

In 2025 President serves 1st year, Vice President serves 1st year, Secretary serves 1st year, VP of Membership serves 2nd year Treasurer serves 2nd year, VP Of Programs serves 1st year and SECA Rep serves 1st year

- 2028 President serves 1st year, Vice President serves 2nd year, Secretary serves 2nd year, VP of Membership serves 1st year, Treasurer serves 1st year VP Programs serves 2nd year, SECA Rep serves 1st year
ELECT Secretary and VP Programs
- 2029 President serves 2nd year, SECA Rep serves 2nd year, Secretary serves 1st year, VP Membership serves 2nd year, VP Programs serves 1st year, Treasurer serves 2nd year
ELECT Treasurer and VP Membership
- 2030 President serves 3rd year, SECA Rep serves 3rd year, Secretary serves 2nd year, VP Membership serves 1st year VP Programs serves 2nd year, Treasurer serves 1st year.
ELECT Secretary and VP Programs and President
- 2031 President serves 1st year, SECA serves 1st year, Secretary serves 1st year, VP Membership ,serves 2st year, VP Programs serves 1st year, Treasurer serves 2nd year
